SUBJECT: FREEDOM OF INFORMATION ACT REQUEST
CNE-CNA-C6F 10-005/11-002

This responds to your Freedom of Information Act (FOIA) requests of August 31 and September 1, 2010, in which you seek a list of all guests visiting the USS MOUNT WHITNEY during its visit to the port of Amsterdam on August 24 through 28, 2010 and information on the purpose of those visits. Your request was forwarded to this office by Department of the Navy FOIA office by e-mail on September 10, 2010, and assigned file number CNE-CNA-C6F 10-005/11-002. On September 29 and October 13, 2010, this office corresponded with you by email in an effort to clarify your fee status. You responded to those emails on October 14, 2010.

Please be advised that, pursuant to procedures established in Secretary of the Navy (SECNAVINST) 5720.42F, our search for responsive records encompassed only those records in existence as of the date of your request.

During our search, we examined the files maintained by the USS MOUNT WHITNEY and Headquarters, U.S. SIXTH Fleet. Despite this diligent search, we were unable to locate documents responsive to your initial request. By email dated October 27, 2010, you agreed to amend your request to include lists of all guests invited to visit the USS MOUNT WHITNEY. Please be advised that we have identified records reflecting guests invited to a reception onboard the USS MOUNT WHITNEY during its visit to the port of Amsterdam. That responsive document is enclosed.

You requested a waiver of fees based on your status as a freelance journalist and member of the news media. There are no fees associated with the processing of your request.

If you believe that an adequate search was not conducted, you may consider this an adverse determination of your request that may be appealed, in writing, to Judge Advocate General of the Navy (Code 14), 1322 Patterson Avenue SE, Suite 3000, Washington Navy Yard, DC 20374-5066.

Your appeal must be postmarked within 60 calendar days from the date of this letter to be considered. A statement as to why you believe a diligent search was not conducted should be included and the enclosed copy of this letter should be attached. Both the appeal letter and the envelope should bear the notation, "Freedom of Information Act Appeal."
